2018 GENERAL INFORMATION

PHYSICAL LOCATION OF CAMPGROUND: 43263 National Rd., Belmont, OH 43718.
(Across U.S. Route 40 from the concert venue, within easy walking distance.)

REGISTRATION OFFICE/MAILING ADDRESS: 70245 BANNOCK-UNIONTOWN ROAD, ST. CLAIRSVILLE, OH 43950.

RULES AND REGULATIONS: Our rules, as well as state and local laws, will be strictly enforced for your safety. Violators of these rules will be forced to leave without a refund, and may face prosecution. Security personnel will exercise their own judgment concerning disruptive behavior. Fights, disruptive behavior, violation of the law or of Valleyview's regulations will not be tolerated. **You are responsible to clean up your site before you depart!**

REGISTRATION: We have state approved sites for "primitive" camping (no hook-ups except Super Sites). Advanced reservation guarantees a reserved space to be determined when you arrive. Sites are rolling, open fields with access on gravel roads. Everyone entering our property does so at their own risk. No liability is assumed by owners, managers, or others.

ARRIVALS: We will open at 8 AM on Sunday July 15, 2018. **Everyone must check-in at the registration area whether or not you are pre-registered and before entering the camping area or marking your sites.** If leaving a site unattended, bring signs, stakes, tape, and mark your site clearly and securely. We are **not** responsible for your belongings or for holding sites left unattended. **PLEASE ARRIVE DURING REGISTRATION HOURS BELOW:**

Sunday-Tuesday July 15-17: 8am-8pm;

Wednesday-Saturday July 18-21: 8am-midnight

THE CAMPGROUND WILL CLOSE AT NOON MONDAY, JULY 23, 2018

CAMPING PERMITS: One CAMPING PASS ALLOWS ONE VEHICLE INTO THE CAMPGROUND. Only **one** motorized vehicle is permitted for each site. Stationery campers (on blocks) are a permitted a vehicle. Camping stickers must be attached to your windshield or vehicles will be towed. If you arrive with an additional vehicle, or have friends meeting you in additional vehicles please read the section below for extra vehicles. Please arrive in the vehicle that requires the camping permit, as we will affix a sticker to your vehicle.

WRISTBANDS: No one will be permitted to enter Valleyview without wearing a Valleyview or Boot Hill wristband. No more than 6 people will be permitted on a site. The camping permit includes up to **2 wristbands**; **Four additional wristbands per site** may be purchased upon arrival for **\$35** per wristband. Only the person whose name appears on the registration form may buy the 4 wristbands.

To enter you must be 21 & wearing a Valleyview wristband that we will place on your wrist.

AFTER SHOW CONCERTS: After show concerts on Wednesday thru Saturday are provided free of charge for the enjoyment of our campers only. Any person causing disruption of the show will be evicted without refund.

AGE RESTRICTIONS: AGE 21 WITH A GOVERNMENT ID; or be camping with a parent or legal guardian to enter.

EXTRA VEHICLE LOT: Our lot for extra vehicles is separate from the camping area, but on the same property. We have limited space for registered campers with an extra vehicle, (first-come basis.) Camping is not permitted in the extra vehicle lot. Parked vehicles must display the parking permit, or face towing at your expense. Vehicles with parking passes **are not permitted** to enter the camping area. Campers may purchase this parking permit (\$60 per car for the entire week or \$10 PER DAY FROM ARRIVAL DATE TO Monday morning, regardless of departure date).

**This area will operate under the same rules, regulations, and hours as the main campground. **

MOTORCYCLES: One motorcycle plus tent is permitted on site with a camping permit. A 2nd bike requires a **bike pass (\$60)**, but is permitted to remain on your campsite. **Maximum: 2 bikes, or 1 bike plus vehicle per campsite.**

UNLICENCED VEHICLES: NO GOLF CARTS, QUADS, 4-WHEELERS, DRONES, OR UNLICENSED VEHICLES!!

GLASS: NO GLASS BOTTLES ARE PERMITTED. Glass Bottles pose a danger to you and to your vehicle's tires!

GROUP SITES: GROUPS ARE LIMITED TO 10 SITES PER GROUP; and must be pre-registered by June 30.

LARGE TENTS: If you are renting a large tent for multiple sites, you must be present for the set-up. The maximum size for a large tent is 40' by 60'. The tent and all supports and stakes must fit within the allotted campsites and not obstruct the fire lanes in any way. This also applies to anyone bringing their own large tent.

TENT SITES: You will be permitted **2 TENTS PER SITE**; or **1 RV plus 1 tent**, if they fit in the 1000 sq. foot campsite.

SECURITY: Staff is located at the main office near the entrance. Staff is equipped with radios, and can communicate with the authorities if needed. Additional staff, security, and Belmont County sheriff deputies circulate through the grounds on a regular basis. Please contact them if you need assistance.

SHUTTLE: Our Shuttle operates on a LIMITED basis within our property during daylight hours Thursday-Sunday. IT WILL NOT TAKE YOU TO THE CONCERT VENUE.

PERSONAL BELONGINGS: We are **NOT** responsible for your personal property. We **NO LONGER** offer "20 minute drop-off" for your belongings. Only vehicles with a camping sticker will be permitted to enter the campgrounds.

PLEASE LOCK UP YOUR VALUABLES

FIRE LANES: All roads are fire/emergency lanes and must remain free of all vehicles and obstructions. Unauthorized vehicles in these lanes will be **TOWED** at the vehicle owner's expense.

FIRES: **NO OPEN FIRES, WOOD FIRES OR OUTDOOR FIREPLACES ARE PERMITTED.**

Cooking must be done in grills or barbecues using charcoal or LP gas.

PETS: **ABSOLUTELY NO PETS ARE PERMITTED.** Bringing a pet is cause for immediate eviction!

QUIET HOURS: **EVERY NIGHT 2AM TO 7AM.**

GENERATORS: Generators Hours 7am to 2am. Unattended generators will be turned off by staff. Commercial or industrial generators are prohibited.

SPEED LIMIT: THE SPEED LIMIT IS 10MPH! DO NOT SPEED IN THE CAMPGROUNDS!

PARKING BRAKE: Set your parking brake when you exit your vehicle.

TRASH PICKUP: Place full trash bags in front of your campsite by 9 AM for daily pickup.

When you leave, your campsite must be free of all litter, or you will face fines.

DUMPSTATION, WASTEWATER BARRELS, AND PORTAJONS ARE PROVIDED FOR YOUR CONVENIENCE!

WATER: RV'S SHOULD ARRIVE WITH A FULL TANK OF WATER.
We try to provide water to campsites for a nominal fee. WATER IS NOT DRINKABLE!
Water will not be provided for swimming pools, etc. until camping units have been serviced.

PROHIBITED ITEMS:

- GLASS BOTTLES
- 4 WHEELERS, GOLF CARTS, ATV'S, ETC.
- FIREARMS OF ALL TYPES
- FIREWORKS, SLINGSHOTS, DRONES, AND BALLOON LAUNCHERS
- PETS
- ANY ITEM DEEMED DANGEROUS BY SECURITY

THESE ITEMS WILL BE CONFISCATED IF FOUND, AND WILL BE CAUSE FOR EVICTION WITHOUT REFUND!

THE RULES AND REGULATIONS ARE GOVERNED BY STATE AND LOCAL AUTHORITIES, AND ARE DESIGNED FOR THE SAFETY AND PROTECTION OF ALL CAMPERS. ALL LAWS, RULES, AND REGULATIONS WILL BE STRICTLY ENFORCED. THE PERSON TO WHOM THE CAMPSITE IS REGISTERED ACCEPTS RESPONSIBILITY FOR ALL PERSONS ON HIS/HER SITE.
